Sl. No.	The school is directed to ensure that :
1	total number of sections of the school from class I to X shall be restricted to 12. The optimum number of students shall be restricted to 40 for classrooms size of 500 sq ft and above. Further, the increase of sections shall be subject to specific approval of the Board based on the request of the school as per affiliation bye-law and availability of classrooms of greater than 500 sq ft dimension
2	The school is directed to run atleast 01 section each of bal-vatika I, II & III subject to the maximum bal-vatika permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
3	As per the video link https://www.youtube.com/watch?v=yDvdLeISVSo, a small portion of the school is not covered with the boundary wall and the school is using the rear side of a college building as a boundary wall (video ref time 2:00), which is not acceptable. Further, at the said area, a temporary wooden gate is observed, which may allow unauthorized access to the school's premises and pose a safety hazard. The school is directed to construct the boundary wall on said area as well as to ensure that it should be bounded with concrete boundary wall from all sides with a minimum 6 ft of height and submit a revised video of the complete boundary wall from all sides in continuity along with aerial view in the compliance within 03 months. 4. The school is required to appoint a qualified counselor as per norms and submit the appointment letter along with educational qualifications in compliance within 03 months. 5. The computer lab has only 25 computers which is less than the minimum requirement i.e. 40 computes. Thus, the school is required to procure more computers within 03 months and submit the invoice along with videography in the compliance 6. The school shall conduct training of its teachers with CoE Ajmer within 03 months and submit the compliance.
4	The school is required to appoint a qualified counselor as per norms and submit the appointment letter along with educational qualifications in compliance within 03 months.
5	The computer lab has only 25 computers which is less than the minimum requirement i.e. 40 computes. Thus, the school is required to procure more computers within 03 months and submit the invoice along with videography in the compliance
6	The school shall conduct training of its teachers with CoE Ajmer within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE.
